1. WHO IS ELIGIBLE?

A person who can satisfy their State Branch Committee that they have been engaged in the Cinema/Film Industry:

- a. as an employee or on their own behalf; and
- b. on a regular permanent full-time or on a casual basis, where such engagement has been the person's principal vocation over a minimum period of twenty (20) years at the time of their nomination for Membership of the Society and, in this regard, service in the Cinema/Film Industry outside Australia may be taken into account in determining the period of service;
- c. and where the term Cinema/Film Industry specifically means:
 - i) Cinema Exhibition
 - ii) Film Distribution
 - iii) Production, including key creatives, crew and cast;
 - iv) Post Production
 - v) Administration or Education, specifically covering the film/cinema industry. Examples would include employment in a Government Agency, Archive, law firm, Film Festival, tertiary institution teaching cinema courses, working as a specialist film writer, reviewer or broadcaster.
